# Mammography Certificate

Spring 2025

## Program Location:

- Online
- Clinical Rotation at local Healthcare Facility

The Mammography program is for those who are already a Registered Radiographic Technologist and registered by the American Registry of Radiologic Technologists (ARRT). Completion of the one-semester certificate program prepares students to sit for the national certification examination in mammography offered by the ARRT. The program meets MQSA initial education requirements for mammographers.

New fall graduates who have not yet sat for their ARRT Registry exam may be admitted to the program contingent upon providing proof that they have passed their exam by December 23, 2024. In order to be approved to register for classes prior to sitting for the exam, students must complete and submit the Verification of Graduation form which must be signed by their Program Director. Students who do not submit proof of ARRT Registry by the deadline date, will not be allowed to attend Mammography courses and will need to withdraw from the program courses.

## Mammography Program Admission:

Students seeking admission to the Mammography Program must be fully admitted to the college. See [Admissions](#) on the college website for more information on steps to apply.

In order to be admitted to the program and be able to register for classes, students must email intent to register for Mammography coursework to the Radiography Program Director [Jamie.Bailey@chattahoocheetech.edu](mailto:Jamie.Bailey@chattahoocheetech.edu) with the following:

- 1) Email must be sent from your Chatt Tech student email address.
- 2) Subject Line: "Mammography"
- 3) Student ID#
- 4) Attached proof of Registry as a Radiographer with the ARRT.  
OR
- 5) Verification of Graduation Form

Upon approval, you will receive an email instructing you to register for your courses. You must register for *both* RADT 2520 and RADT 2530. Seats in the Mammography program are first come, first served; an approval email does not guarantee you a seat in the program.
